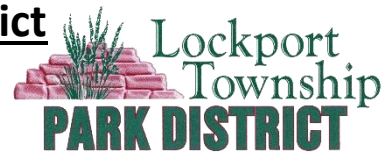

Your rental may be cancelled by District staff to ensure the safety of our guests. Examples may include, but not limited to; inclement weather, maintenance issues or unsafe conditions. In the event we cancel your reservation, you may reserve another date/time, if available, or receive a full refund. Every attempt will be made to reschedule, however due to other scheduling commitments, space may not be available.

Rate for extra clean up time is \$25.00 for every ½ hour after allotted rental time. On the day of the rental if your guest count is over the prepaid rental amount Lockport Township Park District has the right to charge your Household the difference. That balance will remain on your account and may affect future registrations. All rentals must be paid in full to reserve your rental date, No Exceptions.

Outdoor Pool Renter Agreement

- You must be 18 or older to rent Park District facilities.
 - Renters are allowed to enter the facility 15 minutes prior to the rental time for set-up. We cannot make arrangements for items to be dropped off in advance as the facility may be used for other activities. Please check in/out at the facility front desk to gain access to your rental. *If you rent the Multipurpose Room at Chaney Pool other terms may apply.
 - Each rental package is set up for specific guest numbers. Due to safety and the number of lifeguards provided that number is strictly enforced. If you go over the prepaid rental package Lockport Township Park District has the right to charge your Household the difference. The balance will remain on your account until paid.
 - Clean up/exiting rental area must be accomplished within 15 minutes of your scheduled rental end time. Rate for extra clean up time is \$25.00 for every ½ hour after allotted rental time.
 - Guests to your event must remain in your designated area. Use of other areas of the facility is prohibited. There will be park district staff on duty during your rental to assist you with safety and questions (lifeguards and manager). It is the sole responsibility of the hosts to provide supervision for any and all activities during your rental.
 - Guests will have access to the facility locker rooms, showers, pool and other features. We ask that children are supervised in the locker rooms.
 - There may be scheduled programs and additional events or rentals going on near the facility or leading up to the guest's rental time. The rental of any rooms/pool does not include exclusive use of the parking lots. Guests should park in the main lot and enter/exit through the main entrance of the facility.
 - If your child needs a life jacket, it must be Coast Guard Approved – plus an adult 18 years or older must be within arm's reach of that child at all times while he/she is in the pool. Water wings are not allowed.
 - Only swimsuits may be worn in the pool. Cut offs, street clothes including leotards, unlined basketball type shorts and under garments are not permitted in the pool.
 - Swim diapers/little swimmers are required for those children in need of them.
 - Inflatable rafts are not allowed, only soft water toys maybe used. If you plan to bring water toys please discuss with management ahead of time for approval.
 - There is no alcohol, vaping, or smoking permitted on the premise. If alcohol is found, your party will be terminated immediately.
 - Please limited decorations. There is no hanging or taping of decorations on walls, doors or windows. All decorations must be removed and disposed of by the renter.
 - Lockport Township Park District Facilities cannot store ice cream, cake or other cold items. Please make alternate storage plans, such as a cooler with ice. Food may be delivered to the facility please coordinate with the Manager on duty. All food must remain in the designated food area. No glass. Coolers will be checked upon entry.
 - Please refer to the posted pool rules during facility use. Lifeguards will review facility rules with guests at the beginning of the rental. Guests are not allowed to enter the pool/deck area until the lifeguards permit.
 - Trash should be gathered and bagged for maintenance staff to dispose of. It is your responsibility to clear tables, remove table cloths and pick up after your guests. This includes balloons and all other decorations.
 - All functions conducted in LTPD facilities must be in accordance with District standards and, therefore, not be in violation of any Lockport Township Park District regulations or ordinances as set forth in the ordinances providing for the issuances of permits for use of park facilities.
- **Rental includes 15 minutes set-up time, 15 minutes clean-up**
 - **2 hours of party deck/pool, features, locker rooms plus lifeguards**
 - **All rentals must be booked 3 weeks in advance and paid in full to reserve your rental date, No Exceptions.**
